4. Applications must be submitted before the closing date, application received after the closing date will not be considered.
5. The infrastructure related cost/s for the project are not funded under this intervention.
6. The completion of the checklist is compulsory by all Applicants.
7. It is the responsibility of the Applicant to ensure that their application is received by MQA.
8. It is the Applicant's responsibility to inform MQA on changes of the contact person.
9. The application form may not be altered, and it should be used as it is.

3. Please take note that applications are for 2025/2026 financial year and those that are beyond this period will not be considered.
4. Application forms with incomplete and incorrect information and documentation will be disqualified.
5. No faxed / Hand delivered application forms will be accepted.
